PDS also builds upon Pace's longstanding relationships with renowned postwar artists and estates, and decadeslong history in the secondary market.

Emmanuel Di Donna, founder of Di Donna Galleries, brings to the partnership a gallery infrastructure and a focus on high-end, boutique collection curation that will form the foundation for PDS. Over the past fifteen years, Di Donna Galleries has distinguished itself through museum-quality exhibitions and high-value private sales of blue-chip Surrealist, modern, and postwar art. Prior to opening his gallery in 2010, Emmanuel Di Donna was the Vice Chairman of Sotheby's Impressionist and Modern Art Worldwide. He has achieved many world-record private sales of artists and built institutional and private collections of the highest caliber. In summer 2026, the team at Di Donna Galleries will expand to PDS's Upper East Side headquarters, providing the foundational structure and curatorial mission for Pace Di Donna Schrader Galleries.

to guide clients through complex and, at times, sensitive business matters and on structuring large-scale transactions.

Marc Glimcher said, "Pace has always held its historic program to the highest standard, presenting museum-quality exhibitions as far back as the early 1970s. We've brought the same energy of representing living artists to the presentation of great historic figures, which has always been a hallmark of what we do at Pace. This venture—representing a new path for our work in the secondary market—will bring those efforts to a new and unprecedented level of performance."

"For more than two decades, Marc, David, and I have collaborated informally whenever a work, a collection, or a museum project called for a shared perspective," said **Emmanuel Di Donna**. "Formalizing that partnership now feels both natural and timely. Together, we'll be able to offer collectors a truly holistic experience—one that brings every resource under one roof: curatorial insight, market expertise, guidance on acquisitions and deaccessions, and long-standing relationships with institutions around the world. This venture allows us to support our clients with the depth, rigor, and continuity that great masterworks deserve."

"Private sales now represent more than half of all blue-chip transactions," said **David Schrader**. "Our new venture is a strategic and structural response to a market that has outgrown its old architecture. Pace Di Donna Schrader brings together the qualities that matter most to collectors—connoisseurship, discerning judgment, disciplined execution, and a thoughtful long-term approach to building collections. Our focus is simple: to steward important works of art with the rigor and discretion they deserve."

Schrader continued, "Both Emmanuel and I have deep ties with Sotheby's and we look forward to continued collaboration with Sotheby's when it advances our clients' goals."
